 - A. Meeting was called to order at 9:10 AM EST

- IV. Presentation of the Alumni Association
 - A. Not Addressed
- V. Approval of DLSSP Board Meeting Minutes
 - A. District Governor Walaa Ahmed entertained the motion to approve the DLSSP Board Meeting Minutes
 - B. So moved Lieutenant Governor Sean Coyle
 - 1. Lieutenant Governor Ed Kroll seconded

 - D. Motion passes with 11 in affirmation, 0 opposed, and 0 abstentions
- VI. Approval of Tri K Board Meeting Agenda
 - A. District Governor Walaa Ahmed entertained the motion to approve the Tri K Board Meeting Agenda
 - B. So moved Lieutenant Governor Sean Coyle
 - 1. Lieutenant Governor Alyssa Famolari seconded
 - C. Discussion
 - 1. Assistant District Administrator Rich Hall We are going to hold off on doing the board reports until when the Kiwanians are visiting the room, which may be out of order from the agenda
 - D. **Motion passes** with 11 in affirmation, 0 opposed, and 0 abstentions
- VII. Governor's Focus
 - A. This is a very important board meeting in the middle of the year where we can assess our progress and ensure we are on track for the rest of the year and that we gave our all throughout this year
 - B. Doesn't want to be at DCON and think we haven't done all that we could to help the district
 - C. If you don't love what you do, you're not going to do it well
 - D. Sometimes you need to relax and take a break if you think you are having burnout, but there are so many people on the board here to help you when you need to take a breather
 - E. Deadlines are going to be very crucial for the remainder for this service year
 - F. If you cannot make a deadline, you should let Walaa know earlier than just a day or so ahead of time
 - G. DCON is our chance to end the service year perfectly
 - 1. Requires work from every single board member
 - H. Feels so lucky to serve along with the board this year and Walaa is grateful for being able to be here and experience this

- J. We welcome New York District Kiwanis Governor-Elect Steven Sirgiovanni to make a special presentation
 - 1. Has a Circle K International gong that he is giving to us
 - 2. We will donate it to a club that does not have a gong
 - 3. Thanks us for our hard work and time, and encourages us to keep up the good work

VIII. Old Creative Discussion

- A. New York Speaking Recap
 - 1. John Tirino New York Speaking was a lot of fun, and was his first time attending the event
 - 2. Many of our attendees filled out our surveys
 - a. Most people had only good things to say
 - b. Some wanted more service projects or off-site service projects
 - a. There are not many projects in the area, and transportation is such a major issue for anything off-site
 - c. John Keegan We should publish an announcement on why we choose to not do off site service projects
 - 3. How we can learn from our mistakes
 - a. John Tirino We needed more workshops done at the last minute, either a communication or delegation issue
 - a. Walaa Ahmed Didn't want to force certain people to put on certain workshops
 - b. Brian Kenny There is always a lack of attendance at our workshops. We could give more incentive for people to attend
 - c. Elizabeth McGuoirk Liked that workshops were not mandatory, but thinks incentives are great for encouraging attendance
 - d. Jack Curzon We could raffle off registration for a district event based on how many workshops someone attended
 - e. Elizabeth McGuoirk Many people had issues connecting to projectors and having everything ready for the workshop
 - f. John Tirino We should be very explicit in the workshop staging process so everyone understands well the process
 - g. Briana Saur If a presenter needs something for their workshops we need to make sure they have what they need and not assume they will figure it out on their own
 - 4. How can we continue our success
 - a. We have a working google document that everyone can access for DCON planning
 - 5. Greg Faulkner Some members felt that workshops are the same at every district event, and is why people don't attend the workshops. Also might discourage future district event attendance



- 6. Terrell Merritt Make sure there is at least one unique workshop in every workshop period
- 7. Jack Curzon We should put out a survey about what workshops people want to see and attend
 - a. Walaa Ahmed Many people don't fill out our surveys
 - b. Alyssa Famolari If we promote the survey on social media we can get more people to fill them out
- 8. Sean Coyle In the past, some workshop presenter applications only asked for the style of your workshop, but the Conferences & Conventions committee had the final say on what topic was presented
- 9. Tina Lee If we are changing up our workshops, we should spend a lot of time promoting our specific workshops ahead of time
- 10. Sara Louie Rather than having members fill out a survey, we should ask presidents to discuss it out at their meetings and give us the feedback of the club
- 11. Rich Hall New York Speaking was very successful, but there are a number of things we need to work on
 - a. This year at DCON we will be working with a new hotel for the first time
 - b. When we contract a hotel, we have to guarantee that we will have a certain number of rooms booked
 - c. It is extremely important that we expedite the registration process and ensure that it runs smoothly and timely for DCON
 - d. We need to stress that the attendees are responsible for figuring out rooming arrangements, and not leave it up to us to figure out the rooming arrangements for every attendee
 - e. We need to enforce the registration deadlines and encourage clubs to register as a group
 - f. We have a 45 room guarantee to meet for DCON
 - g. We will not randomly assign a room with Male and Females together
- 12. Alison Mandel If you want anything printed, you need to give her time to print it and not send something in the day or so before the event
 - a. We are going to put a cut off and deadline of when you can request printing
- 13. Greg Faulkner We need to ensure that program coordinate is practiced and rehearsed for DCON
- 14. Rich Hall People who need to speak in the script need to know what they are reading ahead of time
- 15. Greg Faulkner A professional session can impact the tone of the weekend and will help motivate and promote attendance
- 16. Rich Hall All audio/visual should be done ahead of time and not during the session
- 17. We are going to give the administrators our deadline list for DCON

- D. Clubs in danger of inactivation
 - 1. Vaughn College
 - a. We are going to call the Dean of Students and speak to the Kiwanis Lieutenant Governor about helping to rebuild the club
 - 2. Utica College
 - a. In communication with director of student activities, and we just need to engage student interest
 - b. We are going to go and table to try and recruit new members for the club
 - 3. St. Lawrence University
 - a. They are an active club but we need to make sure that they are still able to process their dues
 - 4. Hartwick College
 - a. Meeting with school administration to approve the club to be chartered
 - 5. Marist College
 - a. Working on rebuilding the club and in communication with past Key Club Lieutenant Governor to build the club
 - 6. Hudson Valley Community College
 - a. Recruitment and Retention is extremely hard as it is a 2-year school
 - 7. Hunter College
 - a. They have been very inactive, and they have not had any events or meetings recently
 - 8. We are going to visit the clubs that are inactive or in danger of inactivation to work with them in person

 - 1. We need to make sure that all of our clubs pay dues
 - 2. We have had four clubs submit their dues so far
 - 3. No clubs have said they have concerns with paying dues
 - 4. If any club has any concerns about paying dues, you must inform Josh and Walaa so we can address the issue before it's too late



- 5. Brian Kenny Utilize Better World Books to fundraise dues money, you send them your books and they will give you give you money for what books you send them

 - 1. Distributed Kamp Kiwanis 2016 Wish List
 - 2. Costs are rising, but they are trying to keep the cost per child to stay low so clubs can continue to sponsor campers
 - 3. It costs \$600 to send a camper, but if the camper is in the area it may only cost \$450 to send the child as they would not have to pay for transportation
 - 4. If you would like to work at Kamp Kiwanis over the summer as a counselor or volunteer you can look at the application at kampkiwanis.org
 - a. We are going to link the application from our district website

Motion 1 was made by District Secretary Jerry Cimo to add/remove the following text in Article 5 Section 3 of the New York District Bylaws.

- 1. All officers shall assume their official duties as outlined in the Circle K International and District Bylaws.
- 2. District Editor Alyssa Famolari Seconded
- 3. Motion made by Lieutenant Governor Aaron Skulsky to add
 - a. All officers shall assume their official duties as outlined in the Circle K International and District Bylaws. The District Governor shall assume duties outlined in the Circle K International Bylaws.
 - b. Lieutenant Governor Tina Lee seconded
 - c. **Motion passed** with 12 in affirmation, 0 opposed, and 0 abstentions
- 4. Discussion
 - a. Brian Kenny Circle K International will likely not approve this amendment
- 5. **Motion not passed** with 0 in affirmation, 11 opposed, and 1 abstention

Motion 2 was made by District Secretary Jerry Cimo to add/remove the following text in Article 5 Section 5 Subsection a of the New York District Bylaws.

1. The Governor shall have the duty of furthering the objects of Circle K International and promoting the interests of Circle K Clubs within his/her District. He/she shall work closely with other International and District officers to strengthen and expand Circle K.



He/she shall serve as a close liaison to the Kiwanis and Key Club District Governors and Advisors. The Governor shall be the chief executive of the District, shall appoint all standing and special District committees, serve as an ex-officio member of all District committees and shall preside at the District Convention, all District conferences, and all meetings of the District Board of Officers. He/she shall attend the International Convention and all meetings of the International Council. The Governor shall be responsible for the leadership training of club officers, for workshops which will be held at **New York Speaking and** the District Convention, and for developing all communication with clubs for the purpose of bringing administrative aid to said clubs. The Governor shall be responsible for contacting all presidents at least twice a month, and individually contacting each president in the District at least three times throughout the service year. The Governor shall develop and work within an established income and expense budget, and shall work closely with the Kiwanis District Circle K Administrator on all matters dealing with the operation of the District. The Governor may appoint, in consultation with the District Administrator and with the approval of the Board of Officers, an interim counselor to maintain contact with divisions which have no Lieutenant Governor. The District Governor is required to sign a Service Agreement upon the taking of their office and adhere to the terms of said Service Agreement.

Motion 3 was made by District Secretary Jerry Cimo to add/remove the following text in Article 5 Section 5 Subsection b of the New York District Bylaws.

- 1. The Lieutenant Governor shall assist the Governor in the work of the District. He/she shall represent the Governor and have full responsibility under the direction of the Governor in supervising the District executive work in his/her respective division. The Lieutenant Governor shall be charged with helping clubs within the division to increase their membership, complete service projects, and remain up-to-date on the condition of the clubs. The Lieutenant Governor shall also work with the Governor, District Administrator and his/her committee, **District Committees** the Club Building Committee, Kiwanis Lieutenant Governors and area Kiwanis clubs on the building of new clubs and the rebuilding of inactive clubs. He/she shall attend all meetings of the District Board of Officers. He/she will also be required to file a Lieutenant Governor Report form with the Governor, Executive Board, Kiwanis Committee, and the International Counselor at each meeting of the District Board of Officers. The Lieutenant Governors are responsible for finding at least one candidate to succeed them and holding a Divisional Election as outlined in Article V, Section 2. Each Lieutenant Governor is required to sign a Service Agreement upon the taking of their office and adhere to the terms of said Service Agreement. He/she shall also perform such other duties as may be assigned by the Governor or the District Board of Officers.

4. **Motion passes** with 12 in affirmation, 0 opposed, and 0 abstentions.

Motion 4 was made by District Secretary Jerry Cimo to add/remove the following text in Article 5 Section 5 Subsection c of the New York District Bylaws.

- 1. The District Secretary shall keep minutes of the District Convention and of all meetings of the District Board of Officers. Within fourteen (14) days past any special or regular board meeting, he/she shall distribute a complete synopsis of all actions taken, meeting minutes, and notices to the members of the District Board of Officers, the District Administrator, the International Counselor, the District Kiwanis Governor, District Kiwanis Secretary, and all New York District Circle K Club Presidents. He/she shall keep the official District records; shall keep all official club records including collecting all club Monthly Report Forms (MRFs); keep the Governor and Board of Officers informed of club reporting, and service hours status, and district goal progress if such goals are adopted. The District Secretary shall submit a report to the annual convention and at such other times as the Governor and the District Board of Officers may require. He/she shall submit to the proper officials and committees all official communications received from Circle K International. He/she shall maintain the records of all correspondence to the District. He/she shall cooperate with the Governor in forwarding all official reports required by Circle K International. He/she shall also perform such other duties as may be assigned by the Governor or the District Board of Officers. The District Secretary is required to sign a Service Agreement upon the taking of their office and adhere to the terms of said Service Agreement.

Motion 5 was made by District Secretary Jerry Cimo to add/remove the following text in Article 5 Section 5 Subsection e of the New York District Bylaws.

- 1. The District Editor shall collect, edit, and arrange all articles for each issue of the District publication, the number of which is specified by the District Governor. He/she shall publish all directories and addendums as deemed necessary by the Governor or the Board of Officers. He/she shall attend all meetings of the District Board of Officers. The District Editor shall submit a report to the annual convention and at such other times as the Governor and the District Board of Officers may require. He/she shall also perform other duties as may be assigned by the Governor or the Board of Officers. The District Editor is required to sign a Service Agreement upon the taking of their office and adhere to the terms of said Service Agreement.

- 3. No Discussion
- 4. **Motion passes** with 12 in affirmation, 0 opposed, and 0 abstentions.
